- (III) Kerry Trading Co. Limited; or
- (IV) Shangri-la Asia Limited; or
- (V) Kerry Logistics Network Limited.

The items of the Chattels will be determined by the Vendor solely and the Purchaser shall not be entitled to raise any objection thereto. Purchaser of any of the residential properties in the table below is entitled to have the Chattels upon completion of the sale and purchase at no extra consideration. The estimated value of the Chattels is listed out in the table below.
