The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. - (2) Persons interested in submitting tenders of the specified residential properties are reminded to read the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender on a Date of the Sale.
